N. Hawley presented the board with the final revised site plan for the Family Dollar/Dollar General. She stated that the proposal had been reviewed by the township planning commission and that the planning commission recommended it be approved.

The Planning Commission held a Public Hearing on September 26, 2023, and approved text recommendations to the Henrietta Township Zoning Ordinances. On October 12, 2023, the Jackson County Planning Commission reviewed and approved said text amendments. N. Hawley presented the text amendments for the township board's approval.

Moved by A. Faist, supported by S. Kasprzycki to approve the text amendments as presented and reviewed; omitting (2) in 1400.1-Outdoor Lighting-General. Roll Call. Five (5) yes. Carried.

James Moss, owner of Affordable Dumpster, Munith, MI was in attendance. He expressed an interest in leasing/purchasing the township transfer station. A. Grimes stated that the station was not currently for sale and that he felt it was important to retain ownership as the township was able to control costs and operations.

The township will take sealed bids for the sale of its 300-gallon diesel tank with a 110 electric pump. Information will be posted on Henrietta's website and Facebook. Bids must be received no later than 5:00 p.m. December 12, 2023.

Moved by A. Faist, supported by M. McDonald, to adopt a Resolution placing a moratorium on the placement of a shipping container on any parcel in all zoning districts within Henrietta Township

for a period of 365 days for the purpose of receiving information and reviewing and/or revising the current zoning ordinance. Roll Call. Five (5) yeas. Carried.
